FILING DEADLINE FOR **PRIMARY PLATS** IS THE **FIRST TUESDAY** OF EACH MONTH UNLESS IT IS A HOLIDAY. PLATS, STREET PLANS & DRAINAGE PLANS **MUST** BE IN ORDER TO BE ANNOUNCED FOR PUBLIC HEARING. PER COUNTY COMMISSIONERS, ALL STREET AND DRAINAGE PLANS MUST BE IN ORDER ONE WEEK PRIOR TO THEIR MEETING IN ORDER TO BE CONSIDERED. IF STREET OR DRAINAGE PLANS ARE NOT APPROVED, THE PRIMARY PLAT WILL BE CONTINUED BY THE AREA PLAN COMMISSION.

SECONDARY PLATS MAY BE APPROVED BY THE EXECUTIVE DIRECTOR IF IT CONFORMS TO THE APPROVED PRIMARY PLAT. THEY MAY BE FILED ANYTIME **WITH UP TO TWO (2) WEEKS REVIEW BEFORE RECORDING.**

AREA PLAN COMMISSION MEETINGS ARE HELD ON THE **SECOND** MONDAY EACH MONTH. **(UNLESS THERE IS A HOLIDAY)** THE MEETING TIME IS **6:00** P.M. MEETINGS WILL BE HELD IN THE COMMISSIONERS MEETING ROOM, THIRD FLOOR, COURTHOUSE, BOONVILLE, INDIANA.
